Aspirin’s transition from botanical curiosity to medical mainstay unfolded against a backdrop of shifting geopolitical and economic forces. The late 19th and early 20th centuries saw European powers vying for control over raw

material supply chains—willow bark from Central Europe, salicin extraction technologies refined in Germany, and later, mass production capabilities concentrated in industrialized nations. The drug's availability during World War I, distributed to frontline medics for battlefield pain and fever, cemented its role in military and civilian healthcare alike. This period embedded aspirin into the global health infrastructure, transforming it from a luxury to a utility. By the mid-20th century, aspirin's therapeutic profile expanded beyond symptomatic relief. The discovery of its antiplatelet effect in the 1970s—when researchers identified that low-dose

aspirin inhibits thromboxane A₂ production in platelets—revolutionized cardiovascular medicine. This revelation, rooted in geopolitical scientific collaboration between U.S., U.K., and Scandinavian researchers, redefined aspirin’s role in nursing: no longer just a painkiller, but a prophylactic agent against myocardial infarction and stroke.
