Innovations such as prodrugs, liposomal encapsulation, and receptor-mediated transcytosis—pioneered in part by biotech firms in the San Francisco Bay Area and Shenzhen—began to overcome this. Companies like Cerevance and NeuroChel Labs emerged, leveraging nanotechnology and computational modeling to design chelators with enhanced lipophilicity and receptor specificity.
