The World Health Organization’s 2006 Commission on Social Determinants of Health underscored that 80% of disease burden in low-resource settings stemmed from structural factors—poverty, education, environment—yet training programs rarely emphasized systems-level thinking. As middle-income countries expanded their health infrastructure, a paradox emerged: technological advancement outpaced human capital development. In India, for instance, the number of hospital beds per capita grew by 400% between 2000 and 2020, but physician training capacity lagged, creating a mismatch between infrastructure and workforce readiness.

These dynamics converged in the late 2010s, when the Global Health Education Coalition (GHEC) launched a multi-

year initiative to harmonize internal medicine curricula. Its founding members—ACGME, IFMEA, and regional networks from Africa, Latin America, and Southeast Asia—sought a framework that transcended national boundaries while respecting local needs.
