The consequence: Deaf users face repeated miscommunications, eroding trust in digital spaces. Faithfulness demands not just accurate transcription, but deep linguistic adaptation—something current AI systems remain fundamentally incapable of delivering. Expert voices converge on the centrality of community agency. Dr. Maria Santos, a Deaf linguist at Gallaudet University, emphasizes: ‘Faithfulness in sign language is not a technical standard; it is a moral and epistemological commitment. Yet they require ethical frameworks to prevent exploitation—ensuring Deaf communities retain ownership over their linguistic data. Policy must evolve beyond symbolic recognition. Legal frameworks should enforce mandatory faithfulness standards in public communication: judicial proceedings, emergency services, education, and digital platforms. New Zealand’s 2024 Sign Language Act, which requires government agencies to adopt regionally specific signs with community validation, sets a precedent. Equally critical is education: teacher training programs must center Deaf linguists, not just linguistic prescriptivism. In Brazil, pilot programs integrating native signers as educators have boosted student retention by 42%, demonstrating that authenticity drives engagement. Pedagogically, the shift toward immersion and community-based learning marks progress.
