Dewitt's deeper analysis revealed a far more consequential pattern: Aether had functioned as a financial nervous system for a clandestine coalition of state and non-state actors involved in post-9/11 geopolitical recalibrations. The fund's investments—ostensibly in renewable energy startups and tech incubators—served as a veneer for intelligence gathering, influence operations, and the strategic placement of operatives across key nodes in global governance.
