As allies from NATO to ASEAN strengthen their cyber defense doctrines, CMMC's influence extends beyond U.S. borders, with emerging parallels in EU's NIS2 Directive and Australia's Essential Eight, suggesting a convergence toward formalized, certified cybersecurity competencies.
