The risks Paul faced are documented in both his letters and secondary sources. Arrest in Jerusalem (Acts 21-24), trial before Festus and Agrippa, and the perilous voyage to Rome—where execution was likely—underscore the personal cost of his mission. Yet his letters, composed under duress, reveal a man deeply aware of his vulnerability yet unwavering in purpose. His rhetorical strategy—appeals to shared values, appeals to conscience, and appeals to imperial authority—reflects a sophisticated understanding of power, persuasion, and survival. Comparative analysis reveals Romans' uniqueness within early Christian literature. While letters like Galatians emphasize legal freedom from Judaism, Romans engages Judaism at its roots, using Jewish scripture as a foundation for Christian revelation. From a sociological perspective, the epistle's appeal to "all who are God-fearers" (Romans 1:5–7) reveals a deliberate strategy of inclusion. These were non-Jewish sympathizers, often merchants or freedmen, who sought spiritual meaning beyond traditional cults. By welcoming them into a shared faith, Paul expanded the boundaries of religious identity, foreshadowing Christianity's eventual role as a global religion.

Controversially, some scholars—such as feminist theologian Letty Russell—critique Romans 16 for its ambiguous roles, particularly Phoebe as a deacon and Junia as a "prominent apostle." While these passages reflect ancient gender norms, Russell argues they offer critical evidence of women's leadership in early communities, challenging modern assumptions about Paul's views. Such analyses underscore the epistle's complexity and its utility in ongoing debates about equality and authority.

Risks, Persecution, and the Limits of Influence

Paul's mission was fraught with danger. In Jerusalem, he faced hostility from Jewish leaders who viewed his Gentile outreach as heresy. In Antioch, tensions erupted into violence, forcing him and Barnabas to flee (Acts 13–14). Rome, though often seen as a place of safety, carried its own perils: imperial suspicion, exile, and execution were real threats.
