His approach rejected the detached observer model; instead, he embedded himself in Palestinian daily life, often walking streets that had been redrawn by checkpoints, walls, and settlements. Every street corner documented, every wall sketch rendered, every face recorded became a node in a larger cartography of dispossession. The result was not a chronicle of violence alone, but a layered portrait of resilience—of schools operating under curfew, farmers accessing land through permit systems, families preserving homes amid demolition.

Geopolitical and Economic Context: The Layer Beneath the Map

To read *Palestine* without understanding its geopolitical scaffolding is to misread its core. The book unfolds against the backdrop of a century of imperial intervention, post-colonial fragmentation, and Cold War realignments.
