The economic dimension is equally revealing. The funeral industry, valued at over \$100 billion in the U.S. alone, treats biographical content as a high-stakes commodity. Premium programs—custom bindings, archival-quality paper, photographic murals—command premium prices, turning mourning into a marketized experience. This commodification

raises ethical questions: to what extent does commercial pressure shape what is remembered? In Western contexts, disputes arise over contested legacies: should a figure with controversial politics be remembered with full biographical detail, or contextualized with caution? The 2023 funeral of Thomas Sowell in the U.S. sparked debate when his program listed decades of academic work and ideological positions, prompting reflection on how intellectual legacy is biographically framed—elevation or critique. Risks inherent in these biographical selections are manifold. Misrepresentation—whether intentional or accidental—can distort legacy. Inaccurate dates, omitted identities, or omission of marginalized lives risk perpetuating historical erasure.
