The U.S. War on Drugs, launched in the 1970s, exemplifies this fusion: a policy framed as law enforcement evolved into a mass incarceration project, disproportionately impacting Black and Latino communities. By 2020, the U.S. prison population exceeded 2.2 million—among the highest globally—driven not by rising crime rates, but by punitive legislation, mandatory minimums, and racialized policing. This era exposed criminology’s vulnerability to political manipulation, where data and theory were weaponized to justify expansive state power rather than equitable reform. The turn of the 21st century brought globalization’s dual shadow: transnational organized crime and digital criminality.
