But beyond algebra, Islamic astronomers developed spherical trigonometry to model celestial mechanics, enabling precise astronomical predictions. Indian mathematician Madhava of Sangamagrama (14th century) independently developed series expansions—precursors to Taylor series—using infinite processes to approximate trigonometric functions. His work, though unpublished, reveals a parallel development of calculus-like reasoning. In Europe, the absence of a formal framework delayed progress until Newton's **Principia** (1687) and Leibniz's notation system (1684). Yet
