What appeared as organic growth was, in fact, the product of coordinated promotion campaigns, paid shares, and strategic collusion with influencer networks. The leak exposed not just Gigi's practices, but a broader pattern: a shadow economy within OnlyFans where performance metrics were gamed, audience trust weaponized, and labor precarity masked as entrepreneurial freedom. The audit showed that over six months,

engagement spikes were artificially amplified through cross-promotion with other verified creators, fake follower bots, and even coordinated “flood” campaigns designed to game the platform’s recommendation engine. Like many creators, Gigi relied on OnlyFans’ algorithm to amplify reach—posting at peak engagement times, leveraging hashtags, and participating in cross-promotional campaigns with other verified accounts. But what began as organic growth soon revealed a pattern: spikes in visibility correlated not with content quality, but with coordinated efforts—what insiders described as “engagement rings” and bot-assisted promotion. These tactics inflated follower counts, drove recommendation engine favor, and artificially elevated income. Platform data, later leaked, showed that within weeks, certain creators saw engagement jump 300%—a surge that could not be explained by organic reach alone. This discrepancy exposed a deeper flaw: OnlyFans’ recommendation system, designed to reward engagement, incentivized behaviors that prioritized virality over authenticity. The Leaked Audit: Unraveling the Engine

The turning point came in November 2024, when an anonymous leak circulated a 47-page internal audit obtained by investigative journalist Mia Tran, published in *The Global Media Review*. The audit, conducted by an external firm hired

by OnlyFans, detailed systemic anomalies in engagement metrics across dozens of top creators—including Gigi.
