The alloy composition—often a chromium-molybdenum steel—was chosen not only for hardness but for its ability to retain temper under repeated firing cycles, a critical factor in battlefield reliability. Beretta’s engineers understood that a weapon’s lethality was not exhausted at the moment of firing; it persisted through every phase of maintenance, inspection, and repair.
