This framework formalized import licensing, quality control, and stockpile management, with MEWA assuming central coordination. By the early 2000s, Dubai and Karachi had become key logistical hubs,

leveraging their geographic proximity to major rice exporters. The construction of the Riyadh Dry Port and expansion of King Abdulaziz Port enabled faster customs clearance and bulk storage, reducing spoilage and enhancing supply chain efficiency. A pivotal moment came in 2008, during the global food crisis, when export bans and price spikes triggered panic buying across the Gulf. Saudi Arabia responded by establishing a strategic rice reserve—initially 90 days of import cover—stored in climate-controlled facilities in Qassim and Al-Kharj.
