Contrast this with India, where legal ambiguity persists: while the *Juvenile Justice Act* protects children from exploitation, it does not clarify entrepreneurial rights, leaving many youth ventures in regulatory gray. A 2024 report by the Centre for Social Impact notes that 58% of Indian youth entrepreneurs face legal hurdles when seeking bank accounts or contracts—delays that stifle momentum. A 2022 study in *Child Development* found that children exposed to monetized digital activities by age ten exhibit

heightened anxiety around performance and self-worth, fearing failure may jeopardize income or social validation. When ventures scale—through influencer deals or automated sales—the line between play and labor dissolves, risking emotional burnout and distorted economic understanding.

Legal ambiguity compounds these risks. Most jurisdictions grant minors limited legal capacity, yet enforce binding contracts only with parental consent, often without oversight of the minor’s understanding. In the U.S., 38 states require judicial approval for minors to enter binding business agreements, but enforcement is inconsistent. In Nigeria, a 2023 case involving a 12-year-old fashion influencer highlighted this gap: despite generating over \$50,000 in revenue, the creator lacked recourse when a platform terminated her account without explanation, citing “age verification failure.” Such incidents underscore the need for age-appropriate regulatory frameworks that distinguish voluntary entrepreneurial activity from exploitative labor. Financial risk remains a critical concern. Even well-intentioned ventures can collapse under pressure. A 2024 longitudinal study by the University of Cape Town tracked 1,200 youth entrepreneurs under sixteen; 63% failed to sustain operations beyond two years, with 41% citing debt, family pressure, and burnout as primary causes. In regions with weak social safety nets, failure can deepen vulnerability—pushing children into informal, high-risk work rather than sustainable growth. Ethical scrutiny extends to data privacy and digital exposure. Children launching online businesses often share personal information, location data, and payment details—vulnerable to exploitation. In 2021, a surge in teen-run “hobby shops” on social media led to multiple data breaches, with hackers harvesting personal details for identity theft. The EU’s GDPR and COPPA offer partial protections, but enforcement lags in emerging markets, leaving youth particularly exposed. Globally, policy responses vary widely. Scandinavian nations integrate youth entrepreneurship into school curricula with

mandatory ethics training and parental mediation, fostering resilience over profit. In contrast, countries with high youth unemployment, such as South Africa and Brazil, prioritize immediate income generation, often bypassing safeguards.
