Misinformation, historical distrust of biotech, and cultural values shape resistance. In India, for instance, debates around synthetic rice or lab-grown meat intersect with food sovereignty movements and religious dietary laws. Building trust requires transparent communication, participatory governance, and demonstrable benefits rooted in local needs. Economic inequality is another undercurrent. Access to synthetic biology tools remains concentrated among elite research institutions and multinational corporations. Smallholder farmers, low-

income nations, and marginalized communities risk being excluded from benefits—unless deliberate efforts prioritize inclusive innovation. Initiatives like the International Genetically Engineered Machine (iGEM) competition and open-source biolabs aim to democratize access, but systemic barriers endure. Ethical concerns extend beyond safety.
