Their digestive system, adapted to a low-energy, high-fiber diet, reflects this ecological specialization: a four-chambered stomach with microbial fermentation chambers enables efficient breakdown of cellulose, though at a metabolic pace so slow that they may not feed for several hours after foraging.

Similarly, in parts of South America, illegal logging along riverbanks disrupts feeding grounds, forcing manatees into riskier, more populated zones. The emerging blue economy—encompassing renewable energy, sustainable aquaculture, and marine biotechnology—offers both threats and opportunities. Offshore wind farms, while vital for decarbonization, risk disrupting migration corridors if sited without ecological impact assessments. Yet integrated coastal zone management, informed by real-time tracking data from satellite-tagged individuals, allows planners to design infrastructure around critical habitats. This represents a paradigm shift: from reactive conservation to predictive, data-driven stewardship.

Internationally, manatees also feature in debates over wildlife trade enforcement. Despite CITES protections, smuggling networks persist, exploiting weak border

controls. Interpol’s 2023 report identified manatee parts in illicit trade routes from Nigeria to East Asia, where they are sold for traditional medicine or crafts. This underscores the need for intelligence-sharing and cross-border law enforcement—challenges magnified by political instability in key range states.
