Stevenson’s EJI, which has challenged death penalty cases across 12 states, exemplifies a growing transnational legal activism network. The film’s global reception underscores a paradox: while American exceptionalism remains a potent ideological framework, its flaws are increasingly visible to global audiences, fostering cross-border solidarity.

Industry Impact: The Film as Catalyst for Legal Reform and Public Engagement *Just Mercy*'s influence extends far beyond box office numbers—\$30 million globally—into the very architecture of legal advocacy and public policy. Since its release, EJI has expanded its reach, securing the release of over 140 death row inmates and establishing the National Memorial for Peace and Justice in Montgomery, Alabama. The memorial, a haunting landscape of 800 suspended steel squares representing each county where a lynching occurred, transformed a historical trauma into a public monument, forcing communities to confront their complicity. Its design—part memorial, part archive—redefines how societies memorialize injustice, shifting from passive commemoration to active reckoning. In the media landscape, *Just Mercy* recalibrated the role of narrative in legal storytelling. Prior to its release, high-profile criminal cases were typically covered through detached reporting or sensationalist commentary. The film introduced a model where empathy and evidence coalesce: it humanized defendants not as villains or victims, but as complex agents within a broken system. This approach influenced subsequent documentaries like *13th* (Netflix, 2016) and *The Marshall Project*'s investigative series, which blend investigative rigor with emotional resonance. Within legal circles, the film sparked renewed debate over innocence projects and post-conviction review. EJI's success in overturning wrongful convictions—such as that of Walter McMillian, exonerated in 1993 after 22 years—lent credence to calls for systemic reform. Law schools incorporated the film into curricula, using it to teach students how to communicate legal struggles to broader audiences. As anthropologist Arlie Hochschild observed in a 2021 *Global Critical Race Studies* article, 'Just Mercy teaches empathy, but true solidarity requires listening—to whose truth is being told, and how power shapes whose story is told.'

In contrast, Brazil's overcrowded prisons and high rates of police violence reveal a system where mercy remains a privilege, not a right. The film's depiction of Alabama's judicial

neglect mirrors conditions in parts of Southeast Asia, where legal aid is scarce and marginalized groups face arbitrary detention. Yet even in more progressive systems, parallels emerge: the U.K.'s recent reforms to reduce prison overcrowding and Canada's Truth and Reconciliation Commission, which addresses Indigenous overrepresentation in custody, echo *Just Mercy*'s call for institutional accountability. These comparisons reveal a growing global consensus: justice cannot be divorced from equity. Stevenson's work, amplified by the film, contributes to a transnational dialogue on how legal systems might evolve beyond punitive models toward restorative, community-centered alternatives.
