Craigs' work provided a predictive toolkit to anticipate such interactions, shifting the paradigm from reactive repair to proactive optimization. The geopolitical context of the Cold War deeply shaped Craigs' strategic outlook. The era's arms race demanded not just faster or stronger materials, but ones that could endure prolonged operational cycles, harsh environments, and evolving threat landscapes.
