Satellite data from the Indian Space Research Organisation (ISRO) reveals that by the 1990s, this area had become a hotspot for subsidence and salinization, a slow-motion crisis masked by short-term crop yields.

Simultaneously, demographic pressures reshaped the socio-economic landscape. As rural populations grew beyond carrying capacity, land fragmentation intensified. Smallholdings—averaging less than one hectare—became increasingly unviable, driving a wave of internal migration and informal labor migration to urban centers. The land, once a source of subsistence, became a symbol of stagnation and dispossession. By the 2000s, the region's strategic value reemerged not in military terms, but as a frontline in India's struggle for energy

and food security. The discovery of underdeveloped but potentially fertile zones in the Terai prompted the government to classify Chhoti Chut Mota Land as a “priority yet vulnerable ecological-agricultural zone.” This label unlocked limited funding for sustainable land management, but also attracted large-scale investments—often opaque—by private agribusinesses and foreign entities eyeing long-term control through leasehold arrangements and corporate farming models.

Geopolitical and Economic Undercurrents

Environmental economists warn that such shifts risk ecological degradation. Without proper oversight, intensive farming accelerates soil depletion and groundwater overuse, exacerbating the land’s vulnerability. Meanwhile, local NGOs report rising tensions between established cultivators and new arrivals, often from neighboring states, fueling social fragmentation beneath the surface of economic progress.

Expert Perspectives: Voices from the Ground

Academic and fieldwork perspectives illuminate the human and institutional dimensions of Chhoti Chut Mota Land. Dr. Rajiv Kumar, a geographer specializing in Indian land systems, describes the region as a “laboratory of contested modernity”—where tradition and innovation collide under pressure. “Land here is not just a plot,” he explains, “it’s memory, identity, and survival. This cultural dislocation, while less visible than violence or displacement, undermines social cohesion and local resilience.

Industry insiders caution against simplifying the region as a “problem to solve.” Instead, they advocate for hybrid governance

models—combining formal titling with customary recognition, and embedding smallholders in cooperative value chains. “Sustainable development here requires more than titles,” argues Anjali Rao, a rural development specialist. “It needs trust, transparency, and inclusive planning.”

Controversies and Risks: The Shadow of Dispossession
