This activist impulse distinguished early women’s studies journals from conventional academic outlets. They were not merely reflective but generative—aiming to reshape curricula, inform policy, and validate lived experience as legitimate knowledge. The journal format itself was radical: peer-reviewed yet accessible, combining scholarly rigor with a commitment to public engagement. This ethos resonated globally. In the UK, **Feminist Review** (1972) and **Signs** (1975) followed, each adapting to national feminist movements—anti-racist in Britain, anti-dictatorship in Latin America—while sharing a core mission: to dismantle the epistemic monopoly of male scholars. The evolution from newsletters to journals mirrored broader institutional shifts. As women’s studies programs gained tenure-track positions in the 1980s, journals became permanent fixtures, supported by university departments and professional associations. Yet their independence remained vital. Editors often emphasized editorial autonomy, resisting external pressures to conform to mainstream academic norms. This independence enabled bold editorial choices—publishing controversial critiques of patriarchy, integrating interdisciplinary methods, and centering marginalized voices—setting a precedent for feminist scholarship’s radical credibility. In the 1970s and 1980s, the field remained largely concentrated in the United States and Western Europe, shaped by the dominant feminist discourses of those regions. Yet as feminist movements gained momentum in Africa, Latin America, South Asia, and the Middle East, new journal ecosystems emerged—rooted in local struggles, anti-colonial resistance, and regional epistemologies. These publications centered issues like gendered state repression, reproductive autonomy, and indigenous women’s rights, often collaborating with grassroots collectives. Similarly, in South Africa, post-apartheid feminist scholarship gave rise to journals like **African Feminist Forum**, which critiqued how race, class, and colonialism intersected with gender—foregrounding Black women’s experiences long excluded from both nationalist movements and liberal feminism. In Southeast Asia, journals such as **Women and Gender in Asia** (founded 1993) and **Jurnal Studi Perempuan** (Indonesia) navigated complex religious and cultural terrains, engaging with Islamic feminism, caste dynamics, and post-colonial identity. These journals rejected Western-centric frameworks, advocating for contextual analyses that acknowledged local power structures and epistemic traditions. This global diffusion was not merely additive; it reconfigured the field’s theoretical and methodological foundations. Scholars from the Global South introduced concepts like “subaltern agency,” “decolonial feminism,” and “intersectional indigeneity,” challenging universalist claims of Western feminism. The

rise of transnational networks—such as the Association for Feminist Research and the Global Women's Studies Association—facilitated cross-continental dialogue, enabling collaborative research and shared editorial practices. By the 2000s, digital publishing accelerated this decentralization, allowing regional journals to bypass traditional gatekeepers and reach global audiences directly. Today, women's studies journals are no longer peripheral but central to global feminist discourse. Their proliferation reflects a broader epistemic shift: knowledge production is no longer a unidirectional flow from North to South but a polycentric, contested terrain. This transformation has profound implications: it demands humility from Northern scholars, amplifies Southern voices, and redefines what counts as authoritative knowledge.

Economic Pressures and Financial Sustainability in Feminist Publishing

The financial architecture of women's studies journals reveals a persistent tension between mission and market—a struggle emblematic of niche academic publishing in the digital era. From their inception, these journals operated on limited budgets, often relying on university department subsidies, small research grants, or volunteer labor. Early journals like **Women's Studies Quarterly** depended on grassroots fundraising and faculty support, reflecting their roots in activist networks rather than commercial viability. As the academic publishing landscape evolved, women's studies journals faced intensifying pressure to adopt commercial models. The rise of major publishers in the 1990s and 2000s—such as Oxford University Press, Routledge, and Springer—offered expanded distribution but introduced profit-driven imperatives. Many journals transitioned to subscription-based or open-access models, each with distinct economic trade-offs. Open-access, championed as a democratizing force, enabled broader readership—especially in low-income countries—but often shifted costs to authors via article processing charges (APCs), creating new barriers for scholars without institutional funding. Independent journals, such as **Signs** and **Feminist Review** in their earlier years, resisted commercialization by maintaining nonprofit status, relying on institutional partnerships, and cultivating donor support. However, sustainability remained fragile.
