Critics like financial analyst Maria Torres questioned the long-term

viability of a system where coins, despite symbolic weight, remain a minor fraction of monetary circulation. “The U.S. Mint spends millions designing coins annually, yet barely a handful enter circulation,” she observed. “In an era of instant digital transactions, are we investing in currency that matters, or in nostalgia?” The debate extended to the numismatic community, where rare quarters and error strikes command high premiums. For collectors, 2023’s releases were mixed signals: while the American Women quarters lacked precious metal value, their limited mintage and artistic merit fueled secondary market demand. Yet for general circulation, the emotional resonance of coins remained strong—especially among older Americans, for whom a quarter in the pocket evokes personal history and national continuity.

Controversies and Risks: Debasement, Counterfeits, and the Shadow of Trust
