His **Centesimus Annus (1991), written on the cusp of the Cold War's end, confronted the ideological collapse of both Soviet Marxism and unbridled neoliberalism. Here, CST reasserted its relevance in the global order: critiquing the moral vacuity of market fundamentalism while affirming its potential for human advancement when guided by justice. The encyclical emphasized human dignity as an inviolable foundation, rejecting utilitarianism and relativism. It called for a "human ecology"—an integrated view of environment, economy, and social life—decades before the term entered mainstream discourse. This was not abstract idealism; it emerged from witnessing real suffering: Eastern Europe's transition from oppression, Latin America's struggle against dictatorships, Africa's post-colonial disillusionment. CST, once confined to European academies, now spoke to the Global South's lived realities. The 21st century has seen CST adapt to new frontiers: climate change, digital capitalism, migration crises, and the erosion of public trust. Pope Francis's **Laudato Si'** (2015) exemplifies this evolution. More than an environmental encyclical, it is a systemic critique of "technocratic paradigm" and "throwaway**

culture,” diagnosing ecological collapse as inseparable from social injustice. Controversies and risks punctuate CST's trajectory. The Church's historical silence on colonial violence and complicity in oppression remains a stain, undermining its moral credibility. The long-term implications are profound. Similarly, in Asia, bishops engaged with development challenges, advocating for equitable growth amid rapid industrialization. The 1998 **Centesimus Annus Pro Hominitate** by John Paul II deepened this engagement, calling for a “civilization of love” rooted in justice, peace, and environmental stewardship. These decades revealed CST’s capacity to absorb global pluralism while maintaining doctrinal coherence. It transformed from a European pastoral response into a truly international moral framework—one that speaks across cultures, religions, and economic systems. The Church, no longer a monolithic institution, became a polyphonic voice, amplifying the concerns of the marginalized in global forums.

Geopolitical and Economic Context: CST in the Age of Globalization and Inequality

Catholic Social Teaching emerged in direct response to the geopolitical and economic transformations of the 19th and 20th centuries, evolving into a critical lens for analyzing globalization, neoliberalism, and systemic inequality.
