The first draft, circulated internally, introduced the “reality lattice”—a conceptual model where truths are nodes connected by historical, economic, and cultural threads. This lattice became the workbook’s core: a dynamic map to trace how facts gain meaning through layers of influence. The initial version was tested in exposés on corrupt land deals in Colombia and environmental exploitation in the Amazon, demonstrating its utility in complex, high-stakes reporting.
