The secular translation of mindfulness began in earnest in the 20th century, catalyzed by figures like Walpola Rahula and, more influentially, Jon Kabat-Zinn, who founded MBSR in 1979 at the University of Massachusetts. Kabat-Zinn's innovation was not merely decontextualizing meditation, but systematizing it into a secular, time-limited program—eight-week courses with guided exercises, body scans, and mindful movement. This reframing laid the groundwork for clinical adaptation, yet it also initiated a tension: was mindfulness a spiritual discipline or a psychological tool? Early skepticism in medical circles

questioned its empirical basis, but growing evidence of reduced stress, improved emotional regulation, and enhanced self-awareness gradually legitimized its therapeutic potential. By the 1990s, addiction specialists began exploring mindfulness as a counter to the impulsivity and emotional volatility characteristic of substance use disorders. Dr. Alan Marlatt and colleagues at the University of Washington pioneered early studies showing that mindfulness training reduced relapse by fostering awareness of craving triggers and weakening automatic behavioral responses. These findings resonated with a growing recognition that addiction is not solely willpower-driven, but neurobiologically rooted in reward circuitry and self-regulation deficits.
