'But we're pushing the FAA to accelerate updates—especially for BVLOS operations and autonomous systems. Without clearer pathways, we risk playing catch-up to technological capability.' Public safety advocates raise additional concerns. Lisa Chen of the Privacy Rights Clearinghouse warns that drone proliferation, though regulated, amplifies surveillance risks. 'The study guide includes privacy considerations, but enforcement depends on local policies,' she cautions. The regulatory journey of Part 107 has been marked by persistent tensions between deregulation and public safety, revealing a profound enforcement paradox. The rule's core strength—its accessibility—has also become its vulnerability. By mandating only 2 hours of online training under Section 107.127, the FAA prioritized rapid market expansion over deep competency development. This design decision, intended to lower barriers for startups and hobbyists, now invites criticism: how effective is a two-hour module in preparing pilots for complex, high-consequence operations? Incidents underscore this dilemma. The 2018 fatal collision near Los Angeles, where a drone crashed into a helicopter during a routine flight, reignited debates over whether self-

certification was sufficient. Investigations revealed inconsistent pilot preparation, with some operators lacking experience in emergency procedures or spatial awareness. Similarly, in 2021, a drone-edged aircraft collision in rural Texas exposed gaps in real-time airspace monitoring, particularly when drones operated near small airports with limited radar coverage. These events highlight a systemic risk: while Part 107 enables widespread participation, it does not uniformly guarantee capability. Compounding this issue is the fragmented enforcement landscape. The FAA delegates primary responsibility for compliance to local governments, which vary widely in resources and priorities. In dense urban centers like New York and Los Angeles, municipal ordinances restrict drone flights over private property and critical infrastructure, creating a patchwork of rules that operators must navigate. This decentralization complicates enforcement, especially when violations cross jurisdictional boundaries or involve federal airspace. Cybersecurity risks further amplify exposure. Early versions of Part 107 offered minimal guidance on securing drone systems against hacking or spoofing. As drones increasingly rely on GPS, encrypted communications, and remote command links, the attack surface expands. The FAA's 2023 mandate for remote identification (RID) and encrypted command links addresses this, but retrofitting existing fleets remains incomplete. Cyber incidents—such as unauthorized drone hijacking or data interception—pose not just safety threats but privacy and national security concerns. Privacy advocates also challenge the rule's limitations. While Part 107 requires operators to respect privacy, it lacks enforceable standards for data collection, storage, or sharing. Drones equipped with cameras and sensors can inadvertently capture personal information, raising Fourth Amendment and state privacy concerns. The absence of clear regulatory guardrails leaves operators in
