The European Commission’s Article 7 proceedings against Poland reflect a deeper conflict: whether national elites retain the authority to reinterpret constitutional norms or must remain bound by supranational, collectively agreed interpretations. The Polish Constitutional Tribunal’s 2021 ruling that EU law cannot override national constitutional provisions exemplifies a rupture—rejecting a shared framework of guided reading in favor of sovereign reinterpretation.
