A senior investigative journalist and long-form analyst, I've spent years tracing the lineage of data governance, and nowhere is the tension between technical rigor, political leverage, and global asymmetry more palpable than in Dasgupta's body of work. The "goon" here is not violence, but a coercive complicity: institutions that claim objectivity yet serve as instruments of power. This concept crystallized during his landmark 2008 investigation into the methodology of India's Consumer Price Index (CPI). Dasgupta demonstrated how the Ministry of Statistics and Programme Implementation (MoSPI) had systematically understated rural inflation by excluding key food items and adjusting base-year weights. The result was not mere technical error—it was a

macroeconomic illusion that justified austerity policies and masked the true cost of living for India's 70% agrarian population. His work triggered a parliamentary inquiry, led to a Supreme Court review, and catalyzed the establishment of the National Statistical Commission with broader independence. Yet, as Dasgupta himself noted, the underlying tension remained: statistical authority is as much a political construct as a scientific one. The geopolitical roots of this dynamic run deep. In post-independence India, data infrastructure was inherited from colonial survey systems designed for revenue extraction, not governance. The post-1991 liberalization era intensified pressure to produce "market-friendly" statistics to attract foreign investment. Dasgupta observed how international financial institutions—IMF, World Bank—became both arbiters and enablers of statistical legitimacy. Countries sought their validation not just for loans, but for global credibility. This created a feedback loop: national statistical offices dependent on external funding to modernize equipment and training, yet constrained by donor-driven agendas that prioritized OECD-aligned metrics over locally relevant indicators. Dasgupta's work gained global resonance during the 2010s, as debates over "data sovereignty" surged. In countries like Brazil, Turkey, and South Africa, technocrats and civil society groups invoked his framework to challenge state-led data manipulation. In Europe, his critique informed the push for the European Union's Eurostat reforms and the General Data Protection Regulation (GDPR), which enshrined transparency and accountability in data production. But in autocratic and hybrid regimes—Russia, Hungary, parts of Southeast Asia—his insights were weaponized: states weaponized "official" statistics to suppress

His current project—“The Data Integrity Index”—aims to create a globally comparable, open-source framework for assessing statistical credibility, incorporating audit trails, source verification, and public participation. Geopolitically, Dasgupta’s legacy is intertwined with the struggle for data sovereignty. In a world where digital borders are contested, his model offers a path: nations can reclaim statistical autonomy by building transparent, inclusive systems that resist both foreign interference and domestic manipulation. His work challenges the West-centric model of data governance, advocating for pluralistic standards that honor local realities. The BRICS nations’ push for alternative financial data architectures, and the African Union’s Agenda 2063, reflect this shift—direct echoes of Dasgupta’s insistence that data must be a tool of empowerment, not exclusion.

Long-term, the implications are profound. As climate change accelerates, the fundamentals of statistics must evolve to measure not just growth, but resilience—carbon stocks, biodiversity loss, water stress. Dasgupta’s “real-time fundamentals” offer a blueprint. In agriculture, sensor networks and blockchain-verified yields can track food security dynamically. In urban planning, mobile mobility data and energy consumption patterns inform adaptive infrastructure. These systems demand cross-sector collaboration, public-private trust, and legal safeguards—precisely the architecture he has spent decades designing. Yet, the greatest challenge remains institutional inertia. Statistical agencies worldwide, built for a 20th-century paradigm, struggle with digital transformation. Funding remains uneven, skills lag, and political interference persists. Dasgupta’s solution is both technical and cultural: invest in data literacy across societies, empower independent oversight bodies, and embed ethics into statistical education. He argues that “statistical literacy is the new literacy”—a prerequisite for democratic citizenship in the data age. The future of global governance, he suggests, hinges on a quiet revolution: the normalization of fundamentals as a public good. When data is accurate, inclusive, and accountable, it becomes the bedrock of policy that reflects lived realities—not political convenience. Dasgupta’s journey—from uncovering CPI distortions to shaping global data architecture—reveals a deeper truth: statistics are never neutral. They are the language of power. But with rigor, transparency, and justice, they can also be the foundation of truth. As nations grapple with polycrisis—pandemics, climate collapse, inequality—the demand for credible, equitable data has never been higher.
