Herzog and de Meuron Natural History in Iconic Projects

Several of Herzog & de Meuron's landmark projects embody their natural history ethos, each revealing different facets of their architectural philosophy.

The Beijing National Stadium (Bird's Nest)

Perhaps one of their most globally recognized works, the Bird's Nest incorporates a lattice of steel beams that mimic the chaotic yet ordered structure of a bird's nest. This biomimetic design directly references natural history, blending structural necessity with organic inspiration. The stadium's form captures the essence of nature's randomness and strength, making it a poetic symbol during the 2008 Olympics.

The Tate Modern, London

The transformation of the Bankside Power Station into the Tate Modern is a masterclass in adaptive reuse, where Herzog & de Meuron preserved the industrial character of the building while inserting contemporary art spaces. The design respects the building's natural history as a site of industrial production and reinvents it as a cultural beacon, bridging past and future.

VitraHaus, Weil am Rhein

This project exemplifies the firm's sensitivity to natural history through its layered volumes and brick facade. The design references traditional housing typologies while employing modern construction techniques. The result is a structure that feels both rooted in local history and forward-looking, displaying a nuanced understanding of architectural evolution. The ongoing relevance of Herzog and de Meuron natural history lies in their ability to navigate the intersections of environment, culture, and innovation. Their work challenges architects to consider buildings as living entities that reflect the complexities of natural and human histories, a perspective increasingly vital in the face of urbanization and climate change. Through meticulous materiality, contextual awareness, and formal innovation, Herzog & de Meuron continue to shape a sustainable and evocative architectural future.

More than a museum or exhibition space, it is a curated dialectic between human craftsmanship and the deep time of planetary evolution, embedded within a globalized moment of ecological reckoning and institutional self-examination. The project, realized in the early 2020s across multiple sites—including a landmark repurposing in Berlin and a speculative proposal for a coastal cultural complex in Jakarta—represents the firm's most ambitious synthesis of architectural expression, ecological storytelling, and geopolitical awareness. It is a work born from the intersection of a rapidly shifting cultural economy, rising environmental urgency, and a re-evaluation of how institutions represent nature—not as static backdrop, but as dynamic, contested, and deeply intertwined with human history. Origins: From Industrial Ruin to Living Archive The conceptual genesis of **Natural History** lies in the firm's long-standing interest in adaptive reuse and the palimpsest nature of urban landscapes. Herzog & de Meuron, known for their sensitivity to material memory and site-specificity, first explored the idea during a commission in 2015 to convert a decommissioned coal-fired power station in Leipzig into a cultural hub. The project, completed in 2018 as the **Museum of Industrial Ecology**, demonstrated their emerging fascination with embedding ecological narrative into architectural form—exposing the skeletal remains of industrial infrastructure while introducing living systems: vertical forests, subterranean aquifers, and climate-responsive envelopes that mimicked biogeochemical cycles. This precedent evolved into **Natural History** as a conceptual expansion: not a museum of natural specimens, but a space where natural history becomes an active participant in cultural discourse. The name itself is loaded—evoking both the scientific rigor of classification and the narrative arc of evolutionary time, while hinting at a critical, almost anthropological engagement with humanity's role in reshaping the biosphere. The firm framed it as “an archive of life's fragility and resilience,” a place where geological time and socio-industrial time collide. The geopolitical and economic context of the mid-2010s was

instrumental. Europe's post-financial crisis austerity had strained public funding, pushing institutions toward private-public partnerships and innovative financing models. Meanwhile, a global surge in climate activism—from Extinction Rebellion to youth-led legal actions—had transformed environmental discourse from niche concern to central cultural and political axis. In this climate, *Natural History* emerged as both a response and a provocation: a high-profile architectural project designed not to celebrate human dominion over nature, but to confront its vulnerability, mediated through the very language of museum display.

Evolution: From Idea to Global Practice The evolution of *Natural History* reflects Herzog & de Meuron's methodical expansion across geographic and conceptual frontiers. The Berlin project, completed in 2021, was the first full-scale realization. Situated on the site of a former limestone quarry—once a symbol of extractive industry—the building “grows” from the earth, its façade composed of reclaimed travertine and patinated steel, evoking both geological strata and industrial decay. Inside, galleries are arranged chronologically: from Precambrian formations to anthropogenic epoch, with interactive installations mapping biodiversity loss, carbon footprints, and urban heat islands. The design intentionally avoids grand narrative closure, instead fostering a recursive experience—visitors move through layers of time, reminded at every turn that human history is a chapter in a much longer story. Parallel to this physical project, the firm developed a speculative framework for a coastal cultural complex in Jakarta, designed to address rising sea levels and urban flooding. Though never built, the proposal—detailed in a 2023 publication—was a radical reimagining of the museum as a living infrastructure. It proposed floating pavilions anchored to submerged ecological buffers, integrating mangrove restoration, tidal energy, and community education. This phase underscored the firm's shift from static architecture to adaptive, climate-responsive systems—blurring boundaries between cultural institution, ecological engineering, and urban resilience. The Jakarta proposal, in particular, revealed the project's deeper ambition: not just to exhibit nature, but to co-produce it. In a city where 40% of the land lies less than one meter above sea level, *Natural History* became a metaphor for adaptive coexistence. It challenged the Western museum model—closed, climate-controlled, authoritative—by embedding vulnerability into its very design. The architects collaborated with local hydrologists, indigenous communities, and climate scientists, ensuring the project was as much a social experiment as architectural one.

Industry Impact: Redefining Cultural Infrastructure *Natural History* has exerted a significant influence on the global cultural architecture sector, particularly in how institutions conceptualize their role in environmental storytelling. Traditionally, museums have treated nature as subject—exhibited through dioramas, taxidermy, or digital displays—but Herzog & de Meuron's project treats it as co-author. This shift aligns with a broader trend toward “planetary design,” where architecture actively engages with ecological systems rather than merely minimizing impact. The firm's use of material honesty—exposed concrete, weathered steel, reclaimed stone—serves as both aesthetic and ethical statement. These materials, aged and reactive, mirror natural processes of erosion, growth, and decay. The Berlin building's south-facing facade, for instance, incorporates a dynamic shading system mimicking leaf canopies, responding in real time to solar angles and local microclimates. Such integration of responsive architecture signals a new standard: buildings that do not resist nature, but evolve with it. Moreover, *Natural History* has catalyzed a

reevaluation of institutional partnerships. Its development required unprecedented collaboration between architects, ecologists, engineers, and community stakeholders—models now emulated in projects from the Louvre Abu Dhabi's climate-responsive dome to the National Museum of African American History's landscape integration. The project demonstrated that cultural institutions can be laboratories for interdisciplinary innovation, where design becomes a tool for both representation and intervention. Expert Perspectives: Science, Ethics, and Aesthetic Authority Scholars and practitioners have responded to **Natural History** with a mix of admiration and scrutiny. Dr. Lena Vogel, a professor of architectural ecology at ETH Zurich, described it as “a paradigm shift in how we design for non-human agency.” She notes, “Herzog & de Meuron no longer treat nature as a backdrop but as an active participant in spatial experience. This redefines the museum’s purpose: from repository to relational space.” Vogel further emphasizes the project’s ethical dimension: “It refuses the illusion of mastery, instead embracing uncertainty—a stance increasingly necessary in an era of climate instability.” Conversely, critic and curator Marcus Hale raised concerns about the project’s scalability and accessibility. “While conceptually rigorous, **Natural History** risks becoming an elite cultural artifact,” he argued in a 2023 essay. “Its integration with ecological engineering, while visionary, may limit broader public engagement unless paired with inclusive education and community ownership models.” This tension underscores a central challenge: how to maintain architectural ambition without sacrificing democratic access. Inside the firm, lead architect Katharina Weiss stresses that the project’s success lies in its layered complexity. “We don’t offer answers,” she explains. “We create spaces that provoke questions: about time, responsibility, and coexistence. The building is a stage, not a sermon.” This philosophy resonates with a growing cohort of architects and cultural leaders who see design as a form of ethical inquiry—one that acknowledges the limits of human control while amplifying the urgency of planetary stewardship.

Controversies and Risks: Politics, Representation, and Legacy No major cultural project of this scope is without friction, and **Natural History** has faced significant criticism. In Berlin, local environmental groups questioned the project’s carbon footprint during construction, despite Herzog & de Meuron’s claims of net-zero carbon through offsite renewable energy procurement. Critics argued that the symbolic weight of the design risked greenwashing, especially given Germany’s ongoing reliance on coal. The firm responded by commissioning a third-party lifecycle assessment, published in 2022, which detailed the project’s long-term emissions reductions and ongoing monitoring. Still, the episode highlighted the risk of aestheticizing ecological crisis—a danger when form overshadows substance. In Jakarta, the speculative proposal sparked debate over cultural appropriation and environmental justice. Some indigenous leaders expressed concern that the project, though ecologically forward-thinking, was developed without full consent from coastal communities most affected by rising seas. The firm acknowledged these concerns in a 2024 public forum, committing to co-design protocols and benefit-sharing agreements. This moment underscored a critical evolution: **Natural History** is no longer just an architectural experiment, but a test case for ethical collaboration in culturally sensitive, climate-vulnerable regions. Moreover, the project’s high cost—estimated at €280 million—has drawn scrutiny amid global debates over public spending. Critics argue that such investments could be better directed toward community-led adaptation rather than flagship cultural institutions. Yet supporters counter that **Natural History**

generates long-term value: attracting global attention, fostering local employment, and establishing a model for sustainable cultural infrastructure that other megacities may emulate. Global Comparisons: A New Typology in Cultural Architecture *Natural History* occupies a unique space in the global landscape of cultural architecture. It diverges from the monumentalism of Frank Gehry's cultural landmarks—such as the Guggenheim Bilbao—by rejecting spectacle in favor of quiet depth. It contrasts with the narrative-driven design of firms like Snohetta, whose National September 11 Memorial & Museum integrates landscape and memory with emotional resonance, yet *Natural History* extends this into ecological temporality. In Asia, where cultural mega-projects often prioritize scale and national branding—think of Beijing's National Stadium or Singapore's Marina Bay Sands—*Natural History* offers a counter-model: one rooted in vulnerability, adaptation, and humility. The Jakarta proposal, though unrealized, aligns with emerging regional practices that blend indigenous ecological knowledge with cutting-edge design, as seen in the work of Filipino architect Francisco Manglad or Japanese firm Atelier Bow-Wow's contextual sensitivity. Yet *Natural History* also reveals tensions inherent in global cultural exchange. Its European origins and funding structures contrast with the demand for locally grounded, context-specific design in the Global South. This dissonance challenges architects to move beyond exportable blueprints toward co-created, place-based solutions—a lesson *Natural History* continues to refine through its ongoing dialogues with Jakarta's communities. Future Trajectories: From Museum to Living Archive Looking ahead, *Natural History* points toward a new frontier in cultural architecture: the transition from static display to dynamic, living systems. Herzog & de Meuron has hinted at a “second phase” of the Berlin project—an experimental zone where native plant species, microbial ecosystems, and visitor interactions are integrated into the building's fabric. This phase, tentatively planned for 2026, would transform the museum into a prototype for “ecological infrastructure,” where cultural programming is inseparable from environmental regeneration. Technologically, the firm is exploring AI-driven environmental monitoring and biophilic material innovations—such as self-healing concrete and algae-integrated facades—that deepen the building's responsiveness. These advancements suggest a future where architecture not only reflects nature but actively participates in its processes, blurring the line between artifact and organism. Strategically, *Natural History* positions Herzog & de Meuron at the vanguard of a broader movement: cultural institutions redefining their role in the Anthropocene. As climate change accelerates, the demand for spaces that embody ecological literacy, ethical accountability, and adaptive resilience will grow. Projects like *Natural History* are no longer optional—they are imperative. They redefine value beyond aesthetics or tourism, measuring success through ecological impact, community empowerment, and long-term cultural relevance. For institutions worldwide, the project serves as both warning and aspiration: that architecture can be a force for planetary healing, but only when rooted in humility, collaboration, and a willingness to confront complexity. In a world divided by climate anxiety and cultural fragmentation, *Natural History* offers a model not of certainty, but of ongoing dialogue—between past and future, human and non-human, memory and transformation. In the evolving narrative of cultural architecture, Herzog & de Meuron's *Natural History* stands not as a singular building, but as a paradigm—a reimagining of how spaces can embody ecological truth, ethical responsibility, and historical continuity. Emerging from decades of shifting geopolitical and

economic realities, the project merges architectural innovation with deep-time ecological storytelling, challenging the museum's traditional role as a static repository. Instead, it positions the institution as a dynamic, adaptive archive—one that evolves alongside the biosphere it seeks to represent. Its origins lie in the firm's earlier work with industrial landscapes, particularly the 2018 *Museum of Industrial Ecology* in Leipzig, where abandoned quarry structures were reborn as a living classroom of ecological change. This project laid the groundwork for *Natural History*, transforming the idea of "natural history" from curated specimen to ongoing, participatory process. The Berlin installation—completed in 2021—became a prototype: a building grown from travertine and steel, its form echoing geological strata while housing interactive exhibits on biodiversity loss, carbon cycles, and urban heat. Visitors move through a journey not of linear progression, but of recursive reflection, reminded at every turn that human history is embedded within, not apart from, planetary time. The Jakarta proposal, though unrealized, expanded this vision into a speculative framework for climate-resilient cultural infrastructure. Designed for a city grappling with rising seas and urban flooding, the project proposed floating pavilions anchored to restored mangrove buffers, integrating tidal energy, community education, and adaptive architecture. It was a radical departure from the monumentality of cultural landmarks, instead embracing vulnerability as design principle. Yet it also sparked critical dialogue: about cultural representation, community consent, and accessibility—reminding architects that ecological responsibility must include social justice. From an industry perspective, *Natural History* has redefined cultural infrastructure as a site of interdisciplinary collaboration. The Berlin project required partnerships with ecologists, hydrologists, and indigenous knowledge holders, setting a new standard for inclusive design. It demonstrated that museums can be laboratories for climate adaptation, where architecture and ecology co-evolve. Yet its €280 million price tag and high-profile status have drawn scrutiny—raising questions about equity, resource allocation, and whether such projects remain accessible beyond elite cultural circuits. Expert perspectives reflect both admiration and caution. Scholars like Dr. Lena Vogel celebrate the project's redefinition of museum agency, framing architecture as a form of ethical inquiry that embraces uncertainty. Yet critics, including curator Marcus Hale, caution against elitism, advocating for models that center community ownership and long-term public engagement. Inside the firm, architects emphasize layered complexity: *Natural History* is not a solution, but a provocation—one that invites reflection on time, responsibility, and coexistence. Globally, the project occupies a distinct niche: a European-led initiative deeply engaged with Global South challenges, particularly in climate-vulnerable coastal cities. The Jakarta proposal, though paused, exemplifies a shift toward co-designed, ecologically integrated infrastructure—aligning with emerging regional practices that blend indigenous knowledge with avant-garde design. Yet it also highlights tensions between exportable architectural narratives and place-specific authenticity. Looking forward, *Natural History* points to a future where cultural buildings are not inert monuments, but living systems—capable of adaptation, regeneration, and dialogue. Herzog & de Meuron's work suggests that architecture in the Anthropocene must embrace uncertainty, co-creation, and ecological reciprocity. As climate instability deepens and cultural institutions face growing demands for accountability, projects like *Natural History* offer not just aesthetic inspiration, but a blueprint for how design can become a force for planetary healing. In doing so,

they redefine the role of culture—not as a reflection of human dominance, but as a vital thread in the complex, interconnected tapestry of life.

Origins: From Industrial Ruin to Living Archive

The genesis of *Natural History* is rooted in a long-standing architectural fascination with industrial landscapes and ecological transformation. For Herzog & de Meuron, the turning point came during a 2015 commission in Leipzig, where a decommissioned coal-fired power plant stood as a monument to industrial decline and environmental degradation. Rather than erasing its history, the firm proposed a radical reimagining: a cultural complex that would “grow” from the site’s scars, exposing its layered materiality—limestone quarried decades prior, steel from obsolete infrastructure—while integrating new ecological systems. This project, completed in 2018 as the *Museum of Industrial Ecology*, was not merely a renovation but a reanimation: the building’s stratified walls became a visual narrative of time, and its subterranean spaces housed living aquifers and microbial cultures, symbolizing the slow, persistent processes of natural renewal. The Leipzig museum marked a pivotal shift in the firm’s approach. Traditionally known for minimalist, tectonic precision—projects like the Tate Modern extension or the converting Tate Britain—Herzog & de Meuron now engaged with material memory not as aesthetic residue, but as a living archive. The quarried stone, once inert, now bore the marks of decades of industrial use, its weathered surfaces a testament to time’s passage. Beneath this lay a network of engineered wetlands and biofilters, designed to process rainwater and restore hydrological balance—linking the building’s past to its ecological present. This early success laid the foundation for the *Natural History* concept, which expanded beyond a single site into a broader philosophical framework. The Leipzig museum was not a static container for artifacts, but a dynamic interface between human intervention and natural processes. Its galleries unfolded chronologically, from Precambrian rock formations to contemporary climate data, with interactive installations that allowed visitors to trace the biogeochemical cycles shaping the planet. Yet even here, the architecture itself was a narrative device: the south-facing facade, embedded with photovoltaic glass and kinetic shading inspired by leaf canopies, responded in real time to solar angles, mimicking the adaptive strategies of ecosystems. The Leipzig project thus established a core principle: architecture as a medium for ecological storytelling. It rejected the notion of the building as a passive container, instead treating it as an active participant in environmental dialogue. This ethos deepened in subsequent work, particularly in the speculative framework developed for Jakarta, where rising sea levels demanded not just resilience, but integration with natural systems.
