Its composition reflects the fractured realities of a people displaced, reconstituted, and searching for identity amid imperial domination. This shift is not accidental; it reflects a theological reorientation. The exile (586–538 BCE) shattered national confidence, yet paradoxically intensified messianic hope. In a world where political sovereignty had been stripped, spiritual vindication became the only viable form of redemption. The psalmist’s cry, “Restore to us the days of old” (Psalm 45:18), resonates not as nostalgia but as yearning for divine intervention in history’s silence. The economic dimension further contextualizes this evolution.
