Iran's cyber units have targeted dissident communities with personalized falsehoods, while Saudi-backed networks in Yemen and Bahrain have deployed narratives to delegitimize opposition movements. The line between propaganda and deception blurs, as actors exploit sectarian divides and historical trauma to engineer consent. The United States, despite its robust institutions, is not immune. Domestic disinformation networks—often tied to political operatives, foreign agents, or commercial interests—target elections, public health, and social cohesion. The January 6th insurrection was not just a political event but a culmination of years of narrative engineering, where false claims about election fraud were amplified through encrypted groups, influencers, and algorithmic reach. What unites these cases is a shared strategy: the exploitation of societal fault lines. The **perfectos mentirosos** do not seek universal acceptance—they aim to fracture consensus, weaken institutions, and create a vacuum filled with confusion and distrust.
