By 2020, global e-waste surpassed 53 million metric tons—more than doubling since 2014—with only 17.4% formally recycled. Microplastics derived from degraded circuit boards and polymers infiltrated water systems, soil, and even the human microbiome. These environmental stressors, combined with rising levels of electromagnetic pollution from 5G rollouts and satellite constellations, formed a toxic milieu in which biological systems operated under chronic subclinical strain. The medical community faced unprecedented challenges. We’ve been measuring peak emissions, not chronic, low-dose exposure.” Environmental health expert Dr. Linh Nguyen highlighted the ecological dimension: “Microplastics from discarded devices enter the food chain with minimal monitoring. These particles carry adsorbed toxins and endocrine disruptors, creating a reservoir of chronic exposure that amplifies the disease’s reach beyond human users into entire ecosystems.” In contrast, industry representatives cautioned against alarmism. A spokesperson for the Consumer Technology Association noted, “We invest billions annually in safety research. Regulatory frameworks are evolving to keep pace. The challenge is not the technology itself, but context—how devices are used, placed, and maintained.” Yet independent researchers countered that industry-led oversight lacked independence. A 2024 exposé by *The Digital Ethics Review* revealed that 89% of clinical trials on wearable health devices were funded by the very manufacturers involved—raising concerns about conflict of interest and suppressed findings. Patient advocate and ethicist Amira Khalil articulated a growing sentiment: “We’re told to ‘optimize’ our digital lives, but no one asks how that optimization affects our health.
