The lesson is clear: even flawless engineering must anticipate real-world variability. Our response was immediate: enhanced inspections, supplier audits, and customer outreach.' The crisis also spurred innovation. By 2012, Nissan introduced a revised serpentine system with improved thermal sensors embedded in the belt, foreshadowing the connected vehicle era. Engineers now
