Her coxcomb charts, her training school, her unrelenting advocacy transformed medicine from a craft into a science of care. In an age of global uncertainty, her story remains a compass—reminding us that truth, rendered visible through data and narrative, is the first step toward justice, and justice the foundation of resilience.
