These efforts aim to localize production, strengthen training, and integrate real-time data flows across regions. But success depends on sustained funding, transparent data sharing protocols, and inclusive governance that empowers local scientists as equal partners—not just data providers. In this context, the role of the clinical microbiologist transcends technical expertise. It demands advocacy, diplomacy, and systems thinking.
