Pilot programs in states like Oregon and Vermont, experimenting with simplified rules and reduced officiating pressure, suggest a potential paradigm shift—though these remain marginal against the entrenched NFHS orthodoxy. The human cost of these rules is increasingly documented. A 2021 study in the *Journal of Athletic Training* found that high school basketball players experience injury rates comparable to collegiate athletes—yet lack equivalent access to recovery protocols. Most crucially, integrating well-being into the rulebook’s DNA—through mandated rest, mental health check-ins, and coach education—would transform governance from compliance to care.
