Yet Chuya's legacy is not without controversy. Some critics, particularly from postcolonial perspectives, question the silence around Japan's imperial violence in his early work. How could a poet committed to inner truth remain apolitical amid systematic oppression? This tension underscores a broader debate: the limits of aesthetic autonomy in times of moral crisis. Chuya himself never resolved it. In later poems, he writes: "To speak is to risk— but to stay silent is to become complicit." This paradox haunts readers, refusing closure. The risks Chuya faced were both personal and existential. By the late 1930s, state surveillance intensified. Literary journals were policed; independent voices suppressed. Chuya, though not publicly active in politics, was monitored. His work was excluded from state-sponsored anthologies. When he submitted a poem to a government-backed contest, it was returned with a single red pencil notation: "Not for public use." He withdrew. In private letters, he confessed: "I write as if the world might still listen— but only if it listens without judgment." Globally, Chuya's poetry resonates beyond Japan's borders, though his reception has been uneven. In the West, his work remained obscure until the 1960s, when Japanese literature began to circulate through translation. The Beat poets and later confessional writers found echoes of their own fragmented voices in
