Moreover, the integration of artificial intelligence into HR processes—from applicant tracking systems to performance analytics—has introduced new audit frontiers. The EU’s proposed AI Act signals a regulatory turning point: high-risk AI systems in employment will face mandatory audits, audit trails, and human oversight requirements.

dominates—over 80% of workers in Nigeria and Kenya operate outside formal HR systems. Audits here remain nascent, often limited to formal sector firms or those serving international clients. Initiatives like the ILO’s Decent Work Country Programs aim to institutionalize audits in gig and agricultural sectors, but infrastructure gaps and weak enforcement constrain progress. Despite these differences, global convergence is accelerating.
