"It's not about condoning piracy," she notes, "but about exposing how legal frameworks fail when they ignore human need." In contrast, Dr. Anand Rao, a copyright scholar at the University of Cape Town, highlights the archive's role in catalyzing policy reform. "Z-Library didn't just break laws—it cracked open a dialogue," Rao asserts. "It forced governments to ask: if the digital age demands open knowledge, should copyright still function as a gatekeeper?" His research shows that post-2015, over 40 countries revised their intellectual property laws, incorporating flexibilities for education and research—developments Paranjape links directly to the pressure exerted by archives like Z-Library. Yet, Paranjape himself acknowledges the risks. "The legal gray zone is unstable," he warns. "When enforcement turns harsh—through DMCA takedowns, indictments, or international pressure—the archive risks being erased, and so is the argument it represents." Paranjape’s work urges a shift from reactive enforcement to proactive design—where laws evolve not in response to crisis, but to embed equity, transparency, and justice into the architecture of knowledge itself.
