Defense teams, conversely, warn of procedural overreach. "F11 often sets the tone for the entire trial," asserts Amine El-Masry, a defense counsel in the Kenya situation case. "If the prosecution's preparation is rushed or evidence-charged, the defense is forced into reactive mode—unfair from the outset." This asymmetry, he argues, undermines the very principle of fair trial. Survivor advocates add another layer. "F11 is where their stories are first dissected—legally, technically," explains Amina Kouyaté, a survivor advocate with the Coalition for the ICC. "If the process lacks empathy, if legal formalism overshadows human dignity, we risk re-traumatizing those who already endured unspeakable harm." This tension between legal procedure and restorative justice remains unresolved, reflecting a broader crisis in transitional justice: how to balance due process with healing.

Controversies and Risks: Selectivity, Legitimacy, and the Shadow of Hypocrisy
