The destruction of the tea was not random—chests were targeted not for their value, but as symbolic severance. Each crate shattered into Boston's harbor was a calculated act of political theater: tea as a metaphor for control, destroyed to reclaim agency. The global context reveals the Boston Tea Party as more than a colonial anomaly—it was a flashpoint in a broader imperial crisis. Britain's East India Company operated across Asia, Africa, and the Americas, functioning as both a trading enterprise and a tool of soft power. The Tea Act was part of a larger effort to stabilize the EIC's finances after years of war-related losses and competitive smuggling.
