The 2023 volcanic eruption in Tonga, where undersea cable failure severed satellite links, exposed how fragile SAR networks can become in isolated regions. Comparative analysis reveals two paradigms. In the Arctic, melting ice opens new shipping lanes but also increases search complexity—extreme cold, darkness, and shifting ice fields demand cold-weather SAR expertise. Norway's SAR fleet, equipped with icebreakers and autonomous surface vessels, exemplifies adaptation. In the Amazon, dense canopy and riverine terrain require collaboration with indigenous communities, whose ancestral knowledge of waterways and weather patterns proves indispensable. The economic footprint of SAR extends beyond direct operations. Insurance premiums for shipping and aviation are directly tied to a nation's SAR readiness.
