This was no dry academic exercise; it was a deliberate attempt to reframe the Old Testament not as a static relic but as a living, contested text. The geopolitical context of the Cold War deeply influenced this project. As the United States and Soviet blocs vied for ideological dominance, religious discourse became a subtle but potent arena. In the West, Protestantism sought to reaffirm moral clarity amid existential fear; in the Global South, decolonized nations reclaimed biblical narratives from Eurocentric interpretations. Tyndale commentaries, published initially in English and soon translated into Arabic, Spanish, Portuguese, Swahili, Hindi, and Mandarin, became tools of soft power and theological resistance. In Nigeria, Kenya, and India, seminaries and lay communities adopted the commentaries as foundational texts, adapting their insights to local struggles—land rights, ethnic conflict, and post-colonial identity.
