The diet industry, estimated at over \$70 billion globally by 2023, thrived not despite this corporate architecture, but because of it—profiting from perpetual dissatisfaction. Behind the scenes, public health institutions and policymakers oscillated between caution and complicity. Dietary guidelines, once grounded in balanced nutrition, often reflected industry pressures. The 2015–2020 U.S. Dietary Guidelines, for instance, softened warnings about sugar and saturated fat under lobbying influence, even as independent research warned of metabolic

harm. Simultaneously, healthcare systems, overwhelmed by rising diabetes and cardiovascular burdens, increasingly relied on pharmacological interventions—GLP-1 agonists like semaglutide—rather than systemic dietary reform. The result was a cycle: diets failed, people regained weight, shame followed, and they returned to the next commercial solution. The scientific understanding of metabolism further complicated the cycle. Early 20th-century models treated calorie balance as a straightforward equation—eat less, lose weight. But decades of research revealed a far more intricate system: hormonal regulation via insulin, leptin, and ghrelin, circadian influences on metabolism, and the role of gut microbiota in energy extraction. Yet these insights were slow to permeate public discourse. Instead, oversimplified narratives persisted—“calories in, calories out,” “fat is bad”—even as metabolic research showed that quality, timing, and psychological context mattered far more than sheer energy deficit. This knowledge gap allowed industries to exploit metabolic myths, selling “detox teas,” “fat-burning supplements,” and “mindful eating” apps that often delivered little more than profit. The social and psychological dimensions of the diet cycle are equally profound. Anthropological studies reveal that food is not merely fuel but a vessel of identity, memory, and belonging. Diets, particularly extreme ones, disrupt these connections, fostering internal conflict. The “yo-yo effect”—repeated weight loss and gain—erodes self-efficacy, feeding anxiety and disordered eating. For many, this becomes a trauma narrative: a body that fails, a diet that fails, a cycle that feels inescapable. Feminist scholars have critiqued the gendered
