By the 1970s and 1980s, family therapy had crystallized into distinct modalities: Bowenian differentiation, Gottman's emotional attunement models, and structural family therapy. These approaches codified core ground rules—boundaries, circular questioning, genograms, and narrative reframing—designed not only to diagnose but to reconfigure relational patterns. Crucially, these rules were not neutral; they reflected Western individualist values, particularly the emphasis on autonomy, self-expression, and conflict resolution through dialogue. The professionalization of family therapy has generated both rigor and controversy. Licensing boards in North America and Europe now enforce strict credentialing, emphasizing evidence-based practice and ethical boundaries. Yet critics argue this formalization risks rigidification—prioritizing protocol over contextual sensitivity. The APA’s 2016 Task Force on Family Therapy, for example, affirmed structural and strategic approaches as evidence-based, but cautioned against blind adherence when families navigate cultural trauma, migration stress, or socioeconomic precarity. The ground rules—once fluid and adaptive—now face pressure to balance clinical efficacy with cultural humility. Technological transformation has further redefined the terrain. Teletherapy, accelerated by the COVID-19 pandemic, disrupted traditional in-person dynamics. Globally, comparative analysis reveals divergent ecosystems. In India, community-based “mental health workers” blend traditional healing with basic family systems principles, adapting ground rules to local idioms of distress. In sub-Saharan Africa, HIV/AIDS-related orphan crises have spawned innovative peer-led family models, prioritizing resilience over pathology. Yet even here, affordability remains a critical hurdle. Out-of-pocket costs, limited provider networks, and insurance reimbursement rates often restrict access to middle- and upper-income families. For-profit clinics and corporate wellness programs have expanded service delivery, but often prioritize lucrative niches—such as corporate stress management or high-end couples therapy—over underserved populations.
