The global educational testing industry, valued at over \$12 billion in 2023, is dominated by a few transnational corporations whose influence extends into national curricula. Pearson, for instance, commands contracts with over 70% of U.S. colleges and thousands of international institutions, bundling MCQ banks with data analytics, adaptive proctoring, and AI-driven feedback. This vertical integration creates a feedback loop: as schools adopt standardized testing to meet accountability metrics, they become dependent on vendors for content, scoring, and even policy design. The result is a market where intellectual assessment is not just evaluated but monetized, with question banks becoming perpetual revenue streams rather than transient tools. This industrialization has profound implications for epistemic sovereignty. Nations adopting global MCQ benchmarks—such as PISA (Programme for International Student Assessment)—increasingly align curricula to meet internationally defined competencies. While this fosters comparability, it risks homogenizing knowledge, privileging cognitive skills measured by Western psychometric models over local epistemologies. The pathology becomes evident when assessments fail to distinguish between knowledge gaps and systemic inequities, reinforcing a cycle where underperformance is interpreted as deficit rather than structural failure. Expert voices reveal growing unease. Dr. Linda Lee, a cognitive psychologist specializing in cross-cultural assessment, argues: 'MCQs promise universality, but they often deliver cultural specificity masked as objectivity. The long-term implications are profound.
