Dr. Elena Marquez, a professor of electrical engineering at the University of Toronto and longtime OSEC reviewer, emphasizes that “safety codes are only as strong as their enforcement and public understanding.” Her analysis highlights a critical insight: technical compliance without community awareness leads to complacency. “A homeowner unaware that AFCIs prevent arc faults remains vulnerable,” she notes. “The 2024 code's public education mandates—requiring utilities to provide multilingual guides and home safety checklists—are a necessary evolution.” From the public utility regulator's perspective, Lisa Tran, chief safety officer at the Ontario Energy Board, underscores the code's role in risk mitigation. “OSEC 2024 is rooted in probabilistic risk assessment,” she explains. “We now quantify failure modes—arc faults, ground faults, equipment degradation—using real-world failure data. This allows us to target resources where risks are highest, rather than applying blanket standards.” Her team's 2023 risk matrix, which identifies high-failure zones in aging neighborhoods, directly informed the 2024 code's prioritized retrofit schedules. Yet, controversy persists. Some industry analysts, including former Ontario utility

regulator Mark Foster, caution that overregulation may stifle innovation. “The code’s pace—while necessary—risks creating compliance bottlenecks,” he observes. “Startups developing next-gen smart grid tech may delay market entry due to protracted certification processes.” This tension reflects a broader global dilemma: how to regulate emerging technologies without hindering progress. Environmental advocates, notably from the Ontario Clean Energy Network, welcome OSEC 2024’s integration of sustainability into safety.
