Sheet music, hymnals, and recordings became exportable cultural goods, reinforcing Western Christian influence even in colonized regions. Yet this commercialization also enabled resilience: communities in remote villages kept the hymn alive through oral tradition, adapting melodies and languages to local idioms. In post-colonial contexts, "Silent Night" has been reclaimed and reinterpreted—sometimes as a symbol of cultural continuity, other times as a contested relic of imperial and missionary legacies.
