In contrast, the U.S. model relies heavily on employer-sponsored insurance and public programs, leaving millions—especially active-duty families—vulnerable to gaps in care. Expert perspectives reveal a growing consensus: couples therapy within TRICARE is underutilized despite strong clinical support. Dr. Laura Weinberg, a clinical psychologist specializing in military family mental health at the National Center for Telehealth and Technology, notes: 'The evidence is clear—structured couples therapy reduces conflict, improves

adherence to treatment plans, and enhances family resilience. But access remains the bottleneck. When a service member is deployed, their spouse often becomes the sole decision-maker for care, yet many lack awareness of benefits or face long waitlists.' Cultural change requires dismantling stigma through education—both within military ranks and the broader public—framing couples therapy not as a sign of failure but as a strategic investment in readiness.
