Geopolitically, the breath test's rise mirrored broader trends in global health innovation. While developed nations adopted LabCorp's model—backed by robust health infrastructures and reimbursement systems—low- and middle-income countries (LMICs) faced stark disparities. In regions where endoscopy remained the gold standard due to cost and training barriers, H. pylori prevalence soared unchecked: sub-Saharan Africa, South Asia, and parts of Latin America report infection rates exceeding 70% in adults. Here, LabCorp's centralized testing model proved less viable. Yet adaptations emerged: point-of-care breath devices, simplified instructions, and mobile lab units began to bridge the gap. Through partnerships with NGOs and government health programs, the company has deployed mobile screening units in Kenya and India, offering breath tests with same-day results and automated treatment recommendations. These initiatives leverage telehealth platforms, allowing remote physician consultations and reducing barriers to care. However, scalability is constrained by infrastructure: reliable electricity, cold chain logistics for reagents, and trained personnel remain inconsistent. Regulatory divergence further complicates global adoption. While the FDA and EU's CE mark validate LabCorp's test, many LMICs lack robust IVD oversight, leading to unauthorized imports and inconsistent quality. Dr. Ngozi Okoye, a health systems specialist at the African Union, argues: "LabCorp's success is admirable, but we must avoid diagnostic colonialism—exporting a U.S.-centric model without local adaptation. We need African-led innovation, validated in our populations, with affordable licensing and technology transfer." Her push for regional IVD manufacturing alliances reflects a broader call for self-sufficiency. Economists weigh in on market dynamics. Professor Rajiv Mehta of MIT's Health Innovation Lab observes: "The breath test market is maturing,

but winner-takes-all risks entrench monopolies. We need policy incentives—grants, tax breaks—for open-source diagnostic platforms that foster competition and reduce costs.
